In consideration of the acceptance of the Enrollment contract by the school, the undersigned agrees to pay all required fees as specified in the Financial Agreement.

I understand that my obligation to pay the fees for the full academic year is unconditional, and that **after July 1**, no portion of fees paid, or outstanding balance will be refunded, or canceled in the event of absence, withdrawal, or dismissal from the school by the above student.

I understand that in signing this Enrollment Contract for the coming academic year, I am agreeing to accept the rules, and regulations of the School, as stated in the current Parent Handbook, including the rule concerning payment of fees, as referred to above.

Enrollment, as specified within this Enrollment Contract, may be canceled by the parents or guardians in writing, without penalty (with the exception of the non-refundable fees) **prior to July 1**. In the event that the child is withdrawn after the school year has begun, the down payment and fees are nonrefundable. If the child is withdrawn for **nonqualified reasons**, the parents or guardians are financially responsible to pay the remaining annual tuition charges.

I understand the school shall have the right to legal action for the collection of school fees and tuition, and that I will be held responsible for all costs of collection, including court costs, and attorney fees.
